Please be advised in accordance with laws and regulations, the statements on containers will change as follows;

- Change of the statements on containers (refer to Attachment A)
 The statements and product number labels on each container of DRYSURF and HI-LUBE
 products will change in accordance with CLP Regulation, Japanese Fire Service Act and
 Japanese Industrial Safety and Health Act.
- Change of statements indication method on 1kg container for fluorine oil-based grease (refer to Attachment B)

The statement will be printed on the container instead of pasting the label.

1. Change of statements on containers according to laws and regulations

The following items will change according to CLP Regulation, Japanese Fire Service Act and Japanese Industrial Safety and Health Act.

The statements on each container of DRYSURF and HI-LUBE products will change as follows:

- ① Pictograph (※1 and ※2) for GHS classification will be shown if the product comes under GHS classification.
- ② The sentences or word of the statements on containers will partially change.
 (MSDS ⇒ SDS, etc.)
- ③ The warranty period and application will be indicated on the product number label.
- ④ The enlarged label will be used, as information stated on the product number label will be increased.
- 5 In connection with the change ④, the design for can and shipping box will change.
- (6) The above changes will be applicable for all the packing.
- ※1 For the products to which Japanese Fire Service Act is applied : Hazardous substances category and classification will be shown on the product number label.
- ※2 For the products containing the substances to be notified under Japanese Industrial Safety and Health Act: The substance name will be shown on the product number label.
- X3 QR code will be printed on the product number label for our in-house management.
